Dear Rep. Herrera-Dy:

This is in reference to your Honor's letter dated 30 January 2019, requesting for a certification from the Office of the Secretary General that the House of Representatives consents to your assumption as director of APOLLO GLOBAL CAPITAL, INC., a publicly listed holding company.

Without prejudice to Section 14, Article VI of the Constitution and relevant provisions of R.A. No. 3019 (Anti-Graft and Corrupt Practices Act)ii and R.A. No. 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees)iii, this Office finds no legal prohibition for an incumbent Member of the House of Representatives to assume the position of director of a publicly listed holding company.

However, neither the Secretary General nor the Speaker, even as the political and administrative head of the House of Representatives, iv possesses such power and duty to oversee a Member's private engagement, business, or profession, which does not involve, affect, or impede the performance of his/her official functions.

Section 14. No Senator or Member of the House of Representatives may personally appear as counsel before any court of justice or before the Electoral Tribunals, or quasi-judicial and other administrative bodies. Neither shall he, directly or indirectly, be interested financially in any contract with, or in any franchise or special privilege granted by the Government, or any subdivision, agency, or instrumentality thereof, including any government-owned or controlled corporation, or its subsidiary, during his term of office. He shall not intervene in any matter before any office of the Government for his pecuniary benefit or where he may be called upon to act on account of his office (Section 14, Article VI, 1987 Constitution).

^{*}Section 3. Corrupt practices of public officers. In addition to acts or omissions of public officers already penalized by existing law, the following shall constitute corrupt practices of any public officer and are hereby declared to be

⁽h) Directly or indirectly having financial or pecuniary interest in any business, contract or transaction in connection with which he intervenes or takes part in his official capacity, or in which he is prohibited by the Constitution or by any law from having any interest (Section 3 (h), R.A. No. 3019).

This being so, no permission, consent, or certification from the House of Representatives is necessary before a Member may assume his/her position as director of a publicly listed holding company.

Section 7. Prohibited Acts and Transactions. — In addition to acts and omissions of public officials and employees now prescribed in the Constitution and existing laws, the following shall constitute prohibited acts and transactions of any public official and employee and are hereby declared to be unlawful:

(a) Financial and material interest. — Public officials and employees shall not, directly or indirectly, have any financial or material interest in any transaction requiring the approval of their office (Section 7 (a), R.A. No. 6713).

Section 3 (i) "Conflict of interest" arises when a public official or employee is a member of a board, an officer, or a substantial stockholder of a private corporation or owner or has a substantial interest in a business, and the interest of such corporation or business, or his rights or duties therein, may be opposed to or affected by the faithful performance of official duty (Section 3 (i), R.A. No. 6713).
