Subject of the Disclosure

Reply to the query regarding the purchase of a 49-percent stake in Poet Blue Ocean Pte Ltd. by Apollo Global Capital, Inc.

Description of the Disclosure

The Company confirms that part of the proceeds of the follow-on offering is proposed to be used for the purchase of a 49-percent stake in Poet Blue Ocean Pte Ltd. subject to regulatory approvals of the aforementioned follow-on offering.

Information Requested

The Company confirms that part of the proceeds of the Company's follow-on offering ("FOO") is proposed to be used to purchase a 49-percent stake in Poet Blue Ocean Pte Ltd. ("Poet"). Poet is a Singaporean company engaged in engineering design and consultancy services supporting mining, oil and gas extraction and offshore exploration activities. It also owns MB Siphon I, a marine barge outfitted with magnetic separator to draw magnetite iron ore from the sea floor.

As of the date of this response, no agreement has been entered into by the Company relating to the proposed acquisition as the same remains subject to the approval of the FOO by both the Securities and Exchange Commission (SEC) and the Philippine Stock Exchange (PSE). As previously disclosed, the Company has filed with the SEC its application for registration of the shares to be issued pursuant to the FOO and has, in accordance with the relevant rules of the SEC, caused the publication in two (2) newspapers of general circulation, last November 20 and 23, 2020, its Notice of Filing with the SEC of the Registration Statement relating to the FOO. The prospectus for the FOO is uploaded in the Company's website - <http://www.apolloglobalcapital.com/prospectus/>.

The necessary board and other approvals relating to the proposed acquisition of Poet will be secured and the relevant disclosures will be made in connection therewith at the proper time.
